LAWS TO CONTROL FORGED IDENTITY

Nowadays, many juvenile children use forged IDs for their various purposes and ignore the consequences when they show these bogus IDs to security personnel's/bar owners, even though they know that their IDs will be seized, but who cares? These forged IDs are used by minor children in bars and usually have them seized. But these children just don't agree that they are lucky to just get away with their ID's sized instead of being subjected to legal actions, which if taken can ruin their career and might result in cancellation of certificate of the bar owners. When a person is using fraud or bogus certificates of birth or driving license, he has to follow legal actions according to the U.S.A laws, which indicate that:

To use other person's ID as your own is not legal.

To possess a fake ID or selling the same to prove fake identity is illegal.

Person who possess/use/distribute fake IDs will be legally charged with category 1 of crime. And if a person uses the fake ID for obtaining weapons, then the category of crime is 6 and the offence is lawbreaking and bound for legal action against him.

To hold/make or issue fake ID that can be misunderstood for authorized government paper is illegal.

As far as purchasing alcohol are concerned, the following laws are executed:

If a person is using a fake driving license/army/academic identification.

Buying alcohols with the use of fake ID cards can face category 3 crime of misbehavior.

Individuals under the age of 21 years should not possess alcoholic drinks.

If caught, they may have to get rid of their driving license for a month to one year.

No individual under the age of 21 should use manipulated or bogus ID, like driving license/certificate of birth/academic ID card to create fake identification or age to buy alcoholic drinks.

Individual violating these laws will be guilty and punished in category 1 crime of misconduct facing minimum \$500 fine or 50 hours society services and losing their driving license for 1 year.

As far as the retailers of alcoholic drinks are concerned, they should be forced to obey law and verify the identification provided by the individuals while purchasing alcoholic drinks, cigarettes or any other constrained items. But the servers in the bar and clerks are allowed to sell the items depending upon:

The presentation of identification proof at their request and match appearance of the individual in the photo of ID proof with officially authorized age (for alcohol: 21 and for tobacco: 18).

Guessing the age of the individual by his physical appearance.

The identification is intact/not tampered/has expiration date.

And if there is any doubt about the validity of the identification, the clerks or bartenders have the right to ask any additional identity of the individual and match it with each other.

Another misuse of bogus IDs is terrorism and migration of criminals with these false identities. So keep you id's safe and secure.
